On 04/05/2010 at 1628 Hours, police were summoned to _____ on a dead body call. The complainant, _____, found her 19 year old daughter, victim _____ deceased from an apparent gunshot wound. One .40 Caliber shell casing was found next to the body. The victim was last seen alive on 04/04/2010 at 2130 hours.

_____ report that on 04/04/2010, around midnight, a green 4 door vehicle was seen parked in the victim's driveway. a gunshot was heard followed by two more. Two males were then seen fleeing the home to a car. the car fled westbound.

A witness, _____ came forward claiming she was on the phone with the "killers" when the homicide occurred. This witness stated the a/p and his brother were holding the victim hostage because she, the victim, owed them money. The witness heard a scream and then the phone went dead. The witness called back but the victim never again answered the phone. The next morning the witness went to the a/p's house looking for the a/p and the victim. When he couldn't locate either person, he decided to kidnap the a/p's wife and her kids so the a/p would release the victim. Later that day the witness received information about the homicide and he transported the a/p's wife to the murder scene and told officers that the a/p's wife knows the people responsible for the killing.

The a/p's wife was interviewed and she stated the a/p and his brothers, _____ left her house on 04/04/2010 at around 2100 hours. The men told her that she needed to go spend the night in a motel because someone owed them some money and "things were going to happen."

A confidential informant came forward stating the a/p and his brothers showed up at _____ in the morning hours of 04/05/2010. They were driving a green vehicle at that time. The informant said the men had blood on their clothing and they cleaned up in apartment _____. The brothers then exchanged guns and two of them left, leaving this a/p behind.

Officers responded on this tip and located the a/p hiding in the closet of _____. A search, under a search warrant, recovered one .40 caliber pistol and magazine. The magazine for the weapon was nearly full or totally full of live ammo when found.

The a/p was interviewed and he told officers that he is an undocumented alien from Mexico. Post Miranda he admitted to being at the victim's home on 04/04/2010 at 2100 hours but he claimed he only knocked on the door. When he did not get an answer he stated he left the area.

The a/p admitted to being in possession of a .40 caliber handgun with ammo and that he hid it as officers entered the apartment.

Based upon the witness statements, that a/p was transported to jail and booked for Agg. Murder, Agg. Robbery, and Possession of a firearm by a restricted person.
